
I am directed to invite your attention to the references cited and to state that the Government of India vide their Notification dated: 27.04.2015, have extended the time limit for carrying out necessary changes in the relevant Conduct Rules relating to different services from eighteen months to twenty one months from the date on which

the Lokpal and Lokayuktas Act 2013 come into force (i.e. 16th January, 2014). Also, in the Notification dated 27.04.2015 the time limit for filing of revised returns by All Public Servants has been extended from 30.04.2015 to 15.10.2015. In view of the present amendments mentioned above, the Annual Returns of Assets and Liabilities under the Lokpal and Lokayuktas Act, 2013, for the years 2014 and 2015 (which were to be filed by 30th April 2015 and 31st July 2015, respectively) may be filed on or before 15th October, 2015.

2. I am, therefore, directed to request you to file the said declarations/returns within the prescribed time limits, in the prescribed forms online in the application in the Property Related Information System (PRISM) for which the navigation has been provided in the Home Page of SPARRAOW in the website of Department of Personnel & Training (www.persmin.nic.in) using your existing NIC user ID and password.
