I am directed to state that the Government in the GO second cited have issued orders implementing the New Pension Scheme for officers of AIS belonging to Tamil Nadu Cadre who were appointed on or after 1.1.2004. Now, it has been decided to enter into an agreement with National Securities Depository Limited (NSDL) as Central Record Keeping Agency (CRA) for availing New Pension Scheme (NPS) for All India Service Officers and another agreement with NPS Trust with Pension Fund Regulatory and Development Authority (PFRDA) for availing the Trustee Bank, Pension Fund Managers' (PFMs) and Annuity Service Provider (ASP) for operationalising NPS scheme for AIS officers of Tamil Nadu Cadre.

2. I am to request you to furnish the NPS Subscriber Registration Form as prescribed (specimen enclosed) by the National Securities Depository Limited, Mumbai which will function as the Central Record Keeping Agency (CRA) for the New Pension Scheme. The said application form may be filled legibly in BLOCK letters in BLACK ink only and furnish the same in triplicate to the Government to process further action in the matter. Also refer general guidelines at instruction page while filling the application form.

3. The officers already having PRAN in their previous service need not furnish their NPS Subscriber Registration form. They may intimate the fact to the Government with their PRAN with due authentication if any.

4. As the entire process has to be completed by the end of May 2017 to enable the Government to enter into the agreement as indicated in para 1 above, I am directed to request you to furnish the filled in subscriber registration form latest by 20th May 2017.
